

The Ports Regulator of South Africa (PR) is a Public Entity created in terms of the National Ports Act, 2005, (Act 12 of 2005) and is mandated to provide economic regulation for the ports industry.



An invitation is extended to all Consultants specialising in Legal Compliance Audits/Scans to provide the Ports Regulator with the following:-

- Perform a Legal Compliance Audit/Scan of Leases and Terminal Operator deemed Licenses in the Port of Durban, in terms of Sections 56 and 57 of the National Ports Act.

An invitation is extended to all Consultants specialising in B-BBEE Compliance assessments to provide the Ports Regulator with the following service:-

- Perform a B-BBEE status review of all Sections 56 and 57 port service providers.

The Regulator requires the assistance of appropriately qualified lawyers to:

- Consider and analyse the current directives in the context of the purposes and functions of the Regulator, ease of access by stakeholders to the Regulator and the parameters of the Act;
- Advise the Regulator, to the extent necessary, on specific legal issues arising out of the directives;
- Finalise the draft amendments to the current directives, having regard to the above.

“(1) *In considering the proposed tariffs in terms of directive 22, the Regulator must have regard to whether the proposed tariffs reflect and balance the following considerations:-*

- (a) *A systematic tariff methodology that is applicable on a consistent and comparable basis;*

An invitation is extended to all Service providers specialising in the review of legislation to provide the Ports Regulator with the following service:-

- Perform a review of the National Ports Act 2005 (Act 12 of 2005) and submit its recommendation regarding possible technical amendments to improve the Act.

An invitation is extended to all Service providers specialising in Employee benefits to provide the Ports Regulator with the following service:-

- carry out an employee benefit needs analysis,
- provide and/or administer a Pension/Provident fund,
- provide and/or administer a Medical Aid Scheme, and
- provide and/or administer a Group Life Scheme.

An invitation is extended to all Service providers specialising in the analysis of tariff methodologies, to provide the Ports Regulator with the following service:-

- an in depth analysis of an appropriate tariff methodology approach to analyse the yearly tariff application received from the National Ports Authority in terms of the Act, and
- provide the Ports Regulator with a recommendation on the most appropriate tariff methodology approach.

An invitation is extended to all Service providers specialising in carrying out satisfaction surveys and analysis to provide the Ports Regulator with the following service:-

- Perform a satisfaction survey of the top 20 stakeholders (list of top 20 stakeholders will be provided by the Ports Regulator to the successful bidder).
- Pre-printed survey forms to be completed and submitted to the Ports Regulator.

An invitation is extended to all Service providers specialising in Information Technology Audits to provide the Ports Regulator with the following service:-

- carry out an information technology needs analysis,
- draft a Systems Structure Plan for the Ports Regulator,
- determine the relevance and reliability of the current information systems of the Ports Regulator, and to
- draft specifications for software development.

Suppliers need to submit a valid Tax Clearance Certificate, proof of company/close corporation registration, company profile including details of company shareholders. The profiles must include the cv's of the persons who would provide such services and their respective areas of specialisation. Potential suppliers are required to disclose their BBBEE (Broad-Based Black Economic Empowerment) credentials and certificates. The PR is committed to the provisions of the Procurement Policy Framework Act 5 of 2000; Public Finance Management Act 29 of 1999; the Broad-Based Black Economic Empowerment Act 53 of 2003; and the Supply Chain Management Framework Act of 2005
